### Dr. Matthias Rath / Part I: Analysis



### The scientific key to the eradication almost be seen as a 'reward' for escaping of human diseases

The scientific key towards the reduction and ultimately eradication of human-specific diseases is the recognition that over millennia scurvy was the greatest threat to the survival of our ancestors. Forty million years ago, the metabolism of the ancestors of humans was fundamentally set apart from other species by a genetic mutation that rendered them unable to produce vitamin C (ascorbic acid) from glucose in their bodies. This left all descendants dependent on getting sufficient vitamin C in their daily diet, which was rarely the case. In particular, during the millenia of aridity in the savannahs of Africa and the ice ages in the north, the human species came close to extinction. They were threatened from childhood on by the deadly consequences of vitamin C deficiency: Severe blood loss through desintegrating blood vessel walls as well as high susceptibility to infections. Survivors of this predicament were those individuals and groups who inherited biological features that protected their blood vessels from breaking apart during prolonged malnutrition.

This fact explains why today's most common diseases among humans are essentially unknown in other species. Cardiovascular diseases – the hardening of the blood vessels –, metastatic cancer – the uncontrolled overproduction of growth factors –, a multitude of human-specific infections associated with vascular inflammation and formation of new blood vessels (angiogenesis) are all 'scurvy defence mechanisms', i.e. they were lifesaving for our ancestors during millennia of nutritional scarcity.

Among the growth factors stimulating the formation of new blood vessels, the group of so-called vascular endothelial growth factors (VEGFs) deserves particular attention; they not only stimulate the repair and new formation of blood vessels, but are also critical for the growth of nerve cells. Thus, overcoming the mortal threat of scurvy pandemics over millenia was also a powerful stimulus for brain extension and higher intelligence — and for the evolution of man. Thus, the evolution of modern humans can

### **Linus Pauling**

It is an amazing fact that this basic knowledge was published more than 30 years ago by the author of this article together with Nobel Laureate Dr. Linus Pauling. Linus Pauling was one of the most eminent scientists of the 20th century. With his landmark book 'The Nature of the Chemical Bond' (1931), he became a 'modern Prometheus', bringing hydrogen, the sun's prime energy carrier, beyond its destructive use in form of the hydrogen bomb. Linus Pauling identified the fundamental role of 'hydrogen bonds' for all processes of life, including the structure of proteins, DNA, and other molecules – discoveries that brought him the Nobel Prize in Chemistry in 1954.

In his later years, he focused on the most important biological carrier molecule of hydrogen in our bodies, ascorbic acid - essential for tissue stability (hydroxylation), biological energy, antioxidant protection and other basic functions. Systematically applying this knowledge to medicine means saving hundreds of millions of lives and laying the foundation for preventive health care, 'Health for All' and Universal Health Care.

### 20th century – century of pharmaceutical genocide

All major countries in the world – East and West - compete for the same key technologies, information technology, artificial intelligence, sustainable energy and others. Only one area is set apart by a fundamental difference between 200 nations of the world seeking health and, on the other side, a handful of Western countries that consider humanity's desire for health a multi-trillion dollar investment opportunity.

 The seed money for this global scam business came from Germany. In the late 19th century, the imperial German government advocated a new national 'health insurance'. However, this insurance essen-

tially covered only patented drugs produced by the emerging German pharmaceutical companies Bayer, Hoechst and BASF. Thus, under the false pretext of providing health to millions, the German government made its subjects pay the seed money for the emerging pharmaceutical investment business. It was the starting point of what would become the largest genocide and global heist in human history.

- The business model: The Western pharmaceutical business is not a health industry, but an investment business thriving on the expansion of human diseases as markets. The 'return on investment' for this multitrillion dollar business comes from newly synthesized and patented synthetic drugs. Prevention and eradication of diseases are counterproductive to this business and are being fought by it.
- The genocidal dimension: By promising health — but investing in diseases as markets — the political and financial stakeholders of the pharmaceutical investment business knew that their entire business model would lead to genocide and the global exploitation of nations.
- World conquest: At the beginning of the 20th century, when the German chemical/ pharmaceutical industry had become the world's leading export nation, the chairman of Bayer, Carl Duisberg, publicly called for this German industry to rule the world.
- World War I: The first step towards this goal was WWI, a devastating war for which this industry even produced the first chemical weapons.
- Natural competition: During the first decades of the 20th century, the health benefits of an entirely new group of plant-derived molecules were discovered — vitamins. These natural molecules were not patentable and, therefore, posed a major threat to the pharmaceutical investment business.
- A deadly threat to the pharmaceutical investment business: Particularly devastating was the Nobel Prize in Medicine in 1937 — awarded for the discovery of the health benefits of vitamin C. By that time, the entire medical and scientific world learned that humans - unlike to other species cannot produce this vitamin in their bodies and are therefore prone to many diseases that are essentially unknown in the animal world. The German pharmaceutical companies, which by that time comprised more than 80,000 employees and subsidiaries in more than 100 countries, feared for the future of their global disease markets and their entire investment business. With the help of another patented technology the production of the explosive TNT from air — they decided to solve this problem by militarily subjugating the entire world under their control.
- The Nuremberg War Crimes Tribunal, Case VI, documents the German chemical/pharmaceutical companies Bayer, BASF and their cartel IG Farben as the makers of TNT, gasoline and all war essential materials for a 6-year war against the entire world.

Embolstered by these neo-colonial economic and political stakeholders, the Apartheid regime decided to eliminate any opposition and incarcerates the leaders of a democratic South Africa.

them, Russia and China, never had colonies of their own and became the historic guarantors of the end of colonialism. Dozens of developing nations were able to declare their independence without fear of retaliation from their former colonial empires. The political and military stakeholders of these powers met this challenge with all forms of neocolonial strategies. The most deceptive of these was the promotion of patented Western Medicine across Africa and the entire developing world as the only form of modern global health. 'Pharmaceutical colonialism' became the most heinous form of neocolonialism (see picture at right).

- The Brussels EU: The new operational platform for this third attempt at world conquest became the Brussels EU. With this construct, the political 'executive' of the chemical/ pharmaceutical interests relocated from Berlin to Brussels – under German leadership. Today, the unelected so-called EU Commission coordinates almost two-thirds of the world's pharmaceutical ex-
- Abuse of the UN: The post-WWII German government continued to serve the global export interests of the phar-

UN-Organisations WHO and FAO it was seeking to ban natural, non-patentable therapies for all member states of the UN, i.e. globally. These lobby efforts, called 'Codex Alimentarius', continue to this day.

• The new role of NATO: In 1989, with the end of the Cold War, the justification for NATO as a military alliance against the dissolved Warsaw Pact, became redundant. Instead of its dissolution, however, NATO was turned into the military arm of the multi-trillion dollar pharmaceutical investment business.

In summary, during the 20th century hundreds of millions of people have died unnecessarily from preventable diseases for one reason: to feed the insatiable greed of the pharmaceutical investment business. Thus, the 20th Century will later be seen as the century of pharmaceutical genocide.

### 21st century — century of liberating human health

500 years ago humankind liberated itself from the shackles of medieval darkness and ushered in modern times. Then, the status quo tried to defend its untenable feudal privileges and slow down the progress of humanity in a 30-year-war that destroyed vast parts of Europe. In a compelling historical analogy, the Western status quo today is ready to sacrifice all of humanity in a world war with the goal to maintain its economic privileges - namely the multitrillion dollar pharmaceutical investment

For humanity to overcome this impasse, it is essential to have a solid historical analysis and, above all, to have the courage to confront the very foundation of this genocidal trillion-dollar business model.

In the same way that the Dark Ages were followed by the Modern Age 500 years ago, will the 'Century of Pharmaceutical Genocide' be followed by the 'Century of Liberation from Human Diseases'.

To accelerate this historical transformation, it is necessary to develop new international initiatives dedicated to implementing this goal. The most promising organizations dedicated to the progress of humanity at this time are the BRICS nations and other new global organizations independent of the devastating influence of the pharmaceutical investment business.

The mission to liberate the world from preventable diseases could become a signature campaign for the BRICS alliance - and the next great goal uniting all humanity. For the developing nations, the reduction and eradication of human-specific epidemics in their countries will be anoher step towards true liberation.

### Eradicating human diseases

### Dr. Matthias Rath / Part II: Strategy

In the first part of this article series, Dr. Rath analyzed the Westernbased pharmaceutical investment business as the major obstacle to global human health and to world peace. In this second part, he presents the strategic steps that must be taken now to reach the goals of 'Health for all' and universal health care worldwide.

### 'Health for all'

In 1978, in its 'Declaration of Alma Ata', the 12 years after the Alma Ata Declaration, I World Health Organization (WHO) proclaimed 'Health for All' as one of the most desirable goals for all humanity. At that time, the WHO was still a largely independent international body, and the influence ness. Together with Nobel Laureate of the pharmaceutical investment business on this organization was limited. In this declaration, the WHO also defined important preconditions for reaching the goal of health for all, including:

- Prevention: An absolute focus on the preventtion of diseases as a first step towards their ultimate elimination.
- Participation: Besides health professionals, people at large must participate. Primary health care must be understandable and doable by everyone.

By the time of the Alma Ata Declaration, more than a dozen Nobel Prizes had already been awarded for the comprehensive health benefits of vitamins and other micronutrients. Regrettably, however, optimum micronutrient supply as one of the most important tools for preventive and primary health care were not even mentioned in this declaration. This was no coincidence. For more than half a century,

was privileged to participate in a scientific advance that would end a 'century of captivity' of global health on behalf of the Western pharmaceutical investment busi-Dr. Linus Pauling, we shared with the world the astonishing fact that heart attacks, strokes, diabetes, high blood pressure and many other diseases that kill millions of people are essentially unknown in species that – unlike humans – produce high amounts of vitamin C in their bodies.

After Dr. Pauling passed away in 1994, this live-saving research was continued at the Dr. Rath Research Institute. Over the past three decades, the team of researchers there developed effective combinations of vitamin C with other plant-derived natural molecules in the fight against today's most common diseases, including:

• Diabetes: Until now, it has remained unexplained why diabetes, a disease that affects half a billion people today, is characterized by the patients' feet becoming insensitive to extreme temperatures. There is, however, a rational explanation for this phenomenon. Over the millenia

Not surprisingly, research today shows that the key to controlling the deleterious consequences of diabetes are specific combinations of micronutrients that are able to regulate all aspects of diabetes: Glucose uptake by body cells, insulin production in the pancreas and even preventing the deposition of dangerous sugar complexes (AGEs) in the walls of blood vessels and other organs. *See the website below for details.* 

• High blood pressure: As with diabetes, the frequency of high blood pressure today has remained unexplained and, thus, has reached 1.3

billion people worldwide. The most common form of hypertension is characterized by an increased diastolic (second) blood pressure value, reflecting the state of contraction of the blood vessels. Thus, genetic disorders with an increased contraction of blood vessels were of similar benefit to our ancestors as diabetes: They increased the food supply for our ancestors. As with diabetes, our research has shown that a combination of vitamin C and specific micronutrients proved to be highly effective in normalizing high blood pressure. • Infections: Vitamin C deficiency not only weakens the walls of blood vessels,

- 3. General health education: While acknowledged by all fields of natural science, the health benefits of vitamins and other micronutrients are still rarely part of medical education and practice. This is due to the malicious influence of the pharmaceutical business on the medical profession throughout the past century. Thus, any preventive health policy must start by lifting this arbitrary ban on natural health education. The role of micronutrients and the principles of molecular medicine and cellular health have to become an integral part of education from kindergarden to retirement homes.
- 4. Participation of the people: For millennia and long before the arrival of the medical profession, plant-based nutrition has been the basis of human health. Modern research now allows us to comprehensively understand the role of micronutrient deficiencies on triggering human diseases and the significance of optimum micronutrient supply in their prevention. Everyone can understand the principles of natural health information and apply them for themselves and in their communities. Thus, primary health care is no longer a privilege of a small group of pharmaceutically oriented health professionals – but the responsibility of everyone.
- 5. Evidence-based medicine: Existing medical treatments have often been introduced under the influence of the pharadvent of systematic, science-based natuproaches must now be vigorously re-evaluated. The adjacent graph shows that over recent decades, one of the fastestgrowing areas of human health has been the field of vitamin and micronutrient benefits for human health.
